Fields of application

M-510 is applied internally & externally as a one coat render. Substrates must have a good mechanical key suitable for rendering.

Consumption

Indicative consumption 15kg/m² at 10 mm nominal thickness.

Directions for use

To prepare fresh render mix the content of the sack with clean water until the proper workability is obtained. It is designed for spray application and can be applied up to 25mm thick in two passes. Manual application is also possible. After it has sufficiently set, the render can be smoothed over with a finishing trowel. Working time depends on the substrate absorptivity, ambient temperature and mixture workability.

Shelf life-Storage


When stored unopened in a dry place at temperatures above 5°C, shelf life is 12 months from date of manufacture.

Packaging

Available in 30 kg sacks (1,44 tons/ pallet) & big bags (1,4 tons)

Remarks

- Mixing time should not be extended in order not to alter the properties of the material.
- Restrictions on weather conditions during application and curing must be respected. Avoid usage under frost or heat.
- Excessive water addition reduces strength with the possibility of causing cracks and crazing.
- The fresh mortar should be used within 30 minutes from adding water.
- The product contains cement and reacts as alkaline with water, so it is classified as irritant. In case of contact with the eyes the area should be washed without delay with plenty of water.
- The quality of application of this material depends on suitable operative skills and product familiarity.
